Dear Ladies and Gentlemen,

with this letter we would like to inform you about the REACH regulation regarding chemicals as well as related activities of BSK & Lakufol Kunststoffe GmbH.

BSK & Lakufol Kunststoffe GmbH, manufacturer of plastic packaging does not produce notifiable substances. According to the regulation (EC) No. 1907/2006, title II, article 7, we are neither producer nor importer in terms of this regulation and thus, not obligated to register. BSK & Lakufol Kunststoffe GmbH sees itself as a downstream user, as defined in title V article 37.

We are continuously in contact with all suppliers to ensure all substances delivered to BSK & Lakufol Kunststoffe GmbH conform to the REACH regulation.

As of 23<sup>rd</sup> of January 2024, we can confirm that to the best of our knowledge, gathered from information provided to us by our suppliers, our products do not contain substances of the current SVHC list of the REACH regulation that defines the threshold values.

Additionally, we observe closely how suppliers implement the REACH regulation, as product safety is crucial to us.

Please understand that we cannot always reply to every single one of the numerous individual requests regarding that topic. Delays are regrettably caused by the registration procedure as defined by the EU and the necessary enormous administrative efforts within in all affected companies through the entire supply chain.
